Thank you for your interest in the
Dallas Fort Worth Metro Golden Retriever Club.

The following steps must be completed by each applicant before they may be considered or accepted to the general membership. **NOTE: The Membership Application on the next page is a fillable form. You can type it on your computer, then print it out and mail it with your dues payment OR you can print it out and fill it in by hand to mail in with your dues payment.**

Complete the Membership application. The application should be attached to this letter and mailed along with the appropriate Dues for the Membership type you are applying for.

Attain a Sponsor. This may be any member of The Dallas Fort Worth Metro Golden Retriever Club, that is in good standing, it is generally the person that introduced you to the Club.

OR

List a minimum of **2 References** that we may contact. Preferably, these references will be dog-related, i.e., your vet, your breeder, your trainer, people in your training class, dog people who are familiar with you and your dogs.

Attend 2 Club meetings, and at your 3rd meeting the attending members will vote on your application to join. *In order to be given credit for attending a meeting, the person must be personally present during the majority of the business portion of a meeting.*

Or

You may attend 1 Club meeting and Volunteer/Work at 1 Event, then at your 2nd meeting the attending members will vote on your application to join.

(Please note, working an Event equates to a minimum of 4 Volunteer hours at said Event)

(Please note, a 15% quorum is required to vote on an applicant as well as an affirmative vote of three-fourths (3/4) of the members present.)

If an applicant has not fulfilled the above requirements within one (1) year of the date the application is received by the Corresponding Secretary, you will receive notice letting you know that to keep your application active a new application fee is required otherwise your application will be dropped.

DFWMGRC BYLAWS...

MEMBERSHIP ELIGIBILITY – ARTICLE II, SECTION 1.

All persons (a) who subscribe to the purpose of the Club, (b) who are in good standing with the American Kennel Club. (c) who are in good standing with the Golden Retriever Club of America, if a member of such organization, (d) who have indicated a willingness to serve the Club in some capacity such as committee member, steward, trophy donor, etc., (e) who shall not have been nor presently engaged in the buying and selling of dogs for resale, and (f) who has not and does not sell puppies in litter lots, are eligible for membership. While membership is to be unrestricted as to residence, the Club's primary purpose is to be representative of breeders and exhibitors in its immediate area.
