Anyone that enjoys the outdoors with his or her dog is invited to participate in the Snake Avoidance Clinic. At this clinic your dog will receive training with a proven method of snake proofing where dogs are taught to recognize and avoid snakes. This can be a very important procedure as most dogs have a natural curiosity about snakes and will not naturally avoid them. Venomous snake bites can cause large vet bills, take several months for full recovery, and in some cases, be fatal for the dog.
